TERMS and CONDITIONS

APPLICATION

- Applicants must complete their application form as approved by TSA and it must be submitted to TSA Administration. The application consists of :

- Application form
- 3 Photos "Stamp Size" (Player Card, Fee Card & TSA record)
- A clear copy of National ID card or a clear passport copy
- Registration fee
- Monthly fees

REGISTRATION AND MONTHLY FEES

- A sum of MRF 200.00 as a monthly fee must be paid by each participant.
- A reduction will be offered according to the following criteria for those participants who wish to settle advance payment for 3 – 6 months. "Year will be counted from January to December".

- Per 1 Month : MRF 300.00 (- 00)
- Per 2 months : MRF 600.00 (- 00)
- Per 3 months : MRF 850.00 (- 50)
- Per 4 months : MRF 1125.00 (- 75)
- Per 5 months : MRF 1400.00 (-100)
- Per 6 months : MRF 1,650.00 (-150)

- Monthly fees must be settled before the 10th day of each month.
- In addition to the monthly fees, a sum of MRF 100.00 will be charged as a registration fee upon application.
- TSA reserves the right to determine the interruption of practices for school exams or other reasonable activities.
- However, monthly fees must be settled throughout the year.
- The registration fees and the monthly fees must be settled for all applications made on or before the 20th day of each preceding month.
- If the application is made on or after the 21st day of preceding month, monthly fees are not required to be settled. However, registration fees and monthly fees for the following months are required to be settled upon application.

AGE CATEGORIES

- The age categories are :
 - **Boys / Girls** : Under-6, Under-8, Under-10, Under-12, Under-14 & Under-16

ATTIRE (Practice Kit)

- **Color**: Red Shirts and Black Shorts or black track bottom and black veil.
- The practice kit includes :
- **Boys** : Sleeveless shirt / Shorts.
- **Girls** : Short sleeved shirt and Shorts or (Long sleeved shirts, track bottoms and veil)
- All participants must wear the appropriate practice kit as approved by TSA.
- Practice kit is available at TSA
- Depending on the availability, the practice kit may be delivered upon request. If it's out of stock, it will be delivered within a maximum of 20 days.

The payments for practice kit must be made with the registration

- The price of the practice kit will be provided to the participants by TSA.

- TSA reserves the right to decide that the TSA name and/or Logo will be printed on the Jersey and/or shorts.
- TSA reserves the right to decide that the sponsor name and/or Logo will be printed on the Jersey and/or shorts.

- All players must be uniformly dressed.
- All male players must tuck their shirts into their playing shorts.
- Female players who wish to wear veils must wear only the veils approved by TSA.

RECOMMENDATIONS

- Recommendations :

- TSA recommends that participants avoid attending any other basketball or sports academies / schools, as it may cause unexpected interruption of their improvement. In principal, the basic philosophy in their skills development could not be maintained.
- Parents / guardians who wish to clear their doubts about their children's development may communicate with their head coach or directly with TSA management.

- Practices :

- All participants must report to practices on time.
- If a participant prefers to report early, he/she must not arrive more than 10 minutes prior to the start time.
- Parents / Guardians of young participants must pick up their children not later than 10 minutes after the end of practice.

PARTICIPATION GUIDELINES

- TSA will expect each participant to comply with the following guidelines for practices and games:

- show consistent attendance at practices and games, and arrive on-time for all activities
- exhibit willingness to try new skills and learn new concepts, and accept positive critique for development
- display appropriate respect for coaches, referees and other participants
- encourage other participants, and display good sportsmanship
- demonstrate good effort in all drills and competitions
